B. U-3142-05-2 USE PERMIT REVIEW for a Head Start program located at 737 South Carlin Springs Road (Campbell Elementary School) (The Community Development Institute (CDI)). (RPC #22-001-086)

C. M. RECOMMENDATION:

Discontinue the subject use permits for the Early Head Start and Head Start Programs at Campbell Elementary School located at 737 South Carlin Springs Road.

ISSUES: Both Head Start programs are no longer being operated at this location. There are no issues.

DISCUSSION: The County Board approved use permits for two head start programs at Campbell Elementary School in December 2005. The Early Head Start and Head Start programs had previously operated successfully at this location until July 2007 and June 2008 respectively. The Early Head Start and Head Start programs gave written notification to the County Child Care Office about their departure from Campbell Elementary School. Since their departure, Early Head Start returned to their primary location at First Presbyterian Church, 601 North Vermont Street where they retained a classroom, and Head Start relocated to the Northern Virginia Family Service, Arlington Child Development Center located at 1801 North George Mason Drive. Therefore, staff recommends that the County Board discontinue the use permits for two head


