SUBJECT: U-2556-87-5 USE PERMIT REVIEW for a child care center of up to 130 children located at Children's House Montessori School, 2425 N. Glebe Road (RPC# 02-062-006).

C.M. RECOMMENDATION:

Renew, subject to all previous conditions, and with a County Board in five (5) years (September 2017).

ISSUES: This is a three (3) year review of a child care center (Children's House Montessori School), and no issues have been identified.

SUMMARY: Children's House Montessori School has been operating at St. Mark's Church since 1987, and the use was expanded in 2006. The applicant is compliant with all the conditions of approval. Staff therefore recommends renewal of the use permit for a child care center, subject to all previous conditions and with a review by the County Board in five (5) years (September 2017).

BACKGROUND: A preschool and day care center were originally approved at this location (St. Mark's Church) in August 1987 for up to 60 children. In 2006, a use permit amendment was approved to expand up to 130 children. The applicant completed renovations and received a certificate of occupancy for the expanded enrollment in August 2008.



DISCUSSION: A preschool use has been open at this location since 1987 without any notable issues. A use permit amendment in 2006 expanded the maximum enrollment to 130 children. No issues have been identified during this review. Therefore, staff recommends renewal of the use permit for a child care center, subject to all previous conditions and with a review by the County Board in five (5) years (September 2017).

Since the last review (September 2009):

Use Permit Conditions: The applicant is in compliance with the approved use permit conditions.

Child Care Office: The applicant is in good standing with the child care office.

Community Code Enforcement: The Community Code Enforcement office has not reported any concerns regarding the renewal of this use.

Fire Marshal's Office: The Fire Marshal's Office has not reported any concerns regarding the renewal of this use.

Police Department: The Police Department has not reported any concerns regarding the renewal of this use.

Neighborhood: The site is located in the Old Dominion Civic Association neighborhood. As of the date of this report, the civic association had not responded to staff's request for comments on this renewal.

CONCLUSION: The applicant continues to operate in compliance with all conditions of the use permit, with no undue adverse impacts to the surrounding community. Staff therefore recommends renewal of the use permit for a child care center, subject to all previous conditions and with a review by the County Board in five (5) years (September 2017).

August 13, 1988	Renewed use permit (U-2556-87-5) for operation of a child care center for up to 60 children, infants to 12 year olds, from 7 a.m. to 6 p.m. weekdays, subject to the previous

	condition and a review by the County Board in three (3) years (August 1991).
August 10, 1991	Renewed use permit (U-2556-87-5) for operation of a child care center for up to 60 children, infants to 12 year olds, from 7 a.m. to 6 p.m. weekdays, subject to the previous condition and a review by the County Board in five (5) years (August 1996).
August 3, 1996	Renewed use permit (U-2556-87-5) for operation of a child care center for up to 60 children, infants to 12 year olds, from 7 a.m. to 6 p.m. weekdays, subject to the previous condition with no further review.
July 8, 2006	Approved use permit amendment (U-2556-87-5) to increase enrollment by 40 children and amend ages to include 1.5 year olds subject to all previous conditions, with revised Condition #1, new Conditions #2, 3, 4, and 5 and a review by the County Board in one (1) year (July 2007).
July 7, 2007	Extended the time to commence the expansion for use permit amendment (U-2556-87-5) to increase enrollment by 40 children and amend ages to include 1.5 year olds for 70 days, subject to all previous conditions, with a review by the County Board on September 8, 2007.
September 8, 2007	Extended the time to commence the expansion for use permit amendment (U-2556-87-5) to increase enrollment by 40 children and amend ages to include 1.5 year olds, subject to all previous conditions, with a revised condition #5, with a review by the County Board in one (1) year (September 2008).
September 13, 2008	Renewed a use permit amendment (U-2556-87-5) to increase enrollment, subject to all previous conditions and a County Board review in one (1) year (September 2009).

September 26, 2009

Renewed a use permit amendment (U-2556-87-5) to increase enrollment, subject to all previous conditions and a County Board review in three (3) years (September 2012).

Approved Conditions:

1. The applicant shall meet the requirements of the Child Care Ordinance, Community Code Enforcement Office, Environmental Health Bureau, and the Fire Marshal's Office, including securing the appropriate assembly permit prior to the issuance of a Certificate of Occupancy.
2. The applicant agrees that parents of students attending the program shall escort their students to and from the school at all times. The applicant will also prepare, in coordination with the Child Care Office, a pick-up and drop-off plan.
3. The applicant agrees that the hours of operation will be weekdays from 7 a.m. to 6 p.m. with a maximum capacity of 130 children. The Child Care Office may determine the final number of children that can be served in the program, not to exceed 130 children, following the required renovations and improvements to the site.
4. The applicant shall designate a neighborhood liaison to communicate with nearby residents and neighbors to address concerns that may be related to the Children's House Montessori School. The name and telephone number of the liaison shall be submitted by the applicant to the Zoning Administrator and the Old Dominion Civic Association.
5. The applicant agrees to work with the church to ensure the trash area is not located adjacent to the neighbor homes on 24th Street North, and that the dumpster is fenced and is maintained in a clean condition. The applicant further agrees to work with the church to ensure trash pick-up complies with Arlington County Code and does not occur before 7 a.m.
